

**WA1A/WABD/WZNS'S "ZAZZA MORNINGS UNIVERSAL ORLANDO RESORT TRIP GIVEAWAY" CONTEST
OFFICIAL RULES**

A complete copy of these rules can be obtained at the offices of radio stations WA1A, WABD, or WZNS (each, a "Station" and collectively, "Stations"), owned and operated by Cumulus Broadcasting LLC, 1800 West Hibiscus Boulevard #138 West Melbourne, FL 32901; 2800 Dauphin St. Ste 104 Mobile, AL; and 225 Hollywood Boulevard, Fort Walton Beach, FL 32548, during available business hours Monday through Friday or by sending a self-addressed, stamped envelope to any of the above addresses.

The Stations will conduct the **WA1A/WABD/WZNS'S "ZAZZA MORNINGS UNIVERSAL ORLANDO RESORT TRIP GIVEAWAY"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. **NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.**

Eligibility. This Contest is open only to legal U.S. residents of each Station's Designated Market Area ("DMA") as defined by Nielsen Audio, age 21 or older at the time of entry with a valid Social Security number, who have not won a prize from the Stations in the last **30 Days** or a prize valued at \$500 or more in the last **30 Days**, and whose immediate family members or household members have not won a prize from the Station in the last **30 Days** or a prize valued at \$500 or more in the last **30 Days**. **Void where prohibited by law.** Employees of Stations, Cumulus Broadcasting LLC, and each of their parent companies, affiliates, related entities and subsidiaries, promotional sponsors, prize providers, advertising agencies, other radio stations serving each Station's DMA, and the immediate family members and household members of all such employees are not eligible to participate. The term "immediate family members" includes spouses, parents and step-parents, siblings and step-siblings, and children and stepchildren. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein.

2. **Contest Period.** The Contest entry period will begin at **8:10 am ET on November 22, 2021** and will **run weekdays at 8:10 am ET through 8:10am ET on December 7, 2021, excluding November 24, 25, and 26, 2021** (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.

3. **How to Enter.**

On-Air: Listen to any of the Station weekdays at 8:00 am ET to 8:20 am ET during the Contest Period. When the Station plays the "cue-to-call" sounder at 8:10 am ET, listeners should call the Station at (844) 999-2992. Caller 1 and 2 to the Station, as determined by the Station in its sole discretion, will play 'Hot Seat': Erika and Tony pair up with listeners and ping pong back and forth giving clues to words to get the listener to guess without saying those words. Team left trying to answer when the buzzer is sounded, loses. Winner gets qualifying prize and is entered for Grand Prize drawing. **Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:** Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished. Station's decisions as to the administration and operation of the Contest and the selection of the potential winners are final and binding in all matters related to the Contest. Failure to verify winner's eligibility may result in disqualification and forfeiture of the prize. Unclaimed prizes may not be awarded. **LIMIT ONE PRIZE PER PERSON.**

4. **Grand Prize Winner Selection.** On or about 9:10 AM ET on TUESDAY DECEMBER 7, 2021, Station will select ONE potential winner(s) of the grand prize in a random drawing from among all qualifiers. The winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within five (5) days of notification or failure to claim the prize within five (5) days of verification as a winner will result in disqualification and forfeiture of the prize.
5. **Verification of Potential Winner.** THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. The potential winner may be notified by email and/or telephone call after the date of random drawing and/or winner determination. The potential winner will be required to sign and return to Station, within five (5) days of the date notice is sent, an affidavit of eligibility and a liability/publicity release (except where prohibited) to claim the prize, if applicable. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. If a potential winner cannot be contacted, fails to sign and return the affidavit of eligibility and/or the liability/publicity release within the required time period (if applicable), or if the prize or prize notification is returned as undeliverable, potential winner forfeits prize. In the event that the potential winner of a prize is disqualified for any reason, Station may award the applicable prize to an alternate winner by random drawing from among all remaining eligible entries. The approximate retail value ("ARV") of each qualifying prize is FOUR HUNDRED TWENTY-SIX AND 00/100 DOLLARS (**\$426.00**).

Grand Prize. ONE (1) Grand Prize will be awarded in this Contest. The grand prize winner will receive:

TWO (2) NIGHTS STANDARD HOTEL ACCOMMODATION (ONE ROOM, QUADRUPLE OCCUPANCY, ROOM AND TAX ONLY) AT UNIVERSAL'S CABANA BAY BEACH RESORT OR AT ANOTHER ON-SITE HOTEL (AS DETERMINED BY UNIVERSAL ORLANDO IN THEIR SOLE DISCRETION). TWO (2) NIGHTS OF OVERNIGHT PARKING AT ON-SITE HOTEL FOR WINNER AND UP TO THREE (3) GUESTS (VALID FOR ONE (1) VEHICLE). FOUR (4) UNIVERSAL ORLANDO 3 PARK 3 DAY PARK-TO-PARK TICKETS FOR GRAND PRIZE WINNER AND UP TO THREE (3) GUESTS.

ARV of the Grand Prize is ONE THOUSAND NINE HUNDRED FIFTY-FOUR AND 28/100 DOLLARS (\$1,954.28).

TOTAL ARV OF ALL CONTEST PRIZES IS: SIX THOUSAND TWO HUNDRED FOURTEEN AND 28/100 DOLLARS (\$6,214.28 ___).

For entry to the prize event(s), each event attendee may be required to show valid proof of vaccination against the COVID-19 virus and/or valid proof of a negative test for the COVID-19 virus within 72 hours (or such other time as the event organizers require) prior to the event(s).

Winner is responsible for all taxes associated with prize receipt and/or use. Odds of winning a prize depend on a number of factors including the number of eligible entries received during the Contest Period and listeners participating at any given time.

Trip must be taken between December 7, 2021 and February 4 , 2022. Travel dates to be mutually agreed upon by winner and Station. Winner and guest must travel on the same itinerary. Winner's guest must be eighteen (18) years of age or older. Minor guests, if any, must be accompanied by a parent or legal guardian. Prize is non-transferable and no substitution will be made except as provided herein in the Station's sole discretion.

Stations and any Sponsors make no representation or warranty about the safety of any prize. Universal City Development Partners, Ltd. d/b/a Universal Orlando Resort ("Universal Orlando") is a prize supplier only in this promotion, is not a sponsor of this promotion and is not responsible for the administration of the promotion, the collection of entries, or the selection of any winner. Each Station reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Contest or to be acting in violation of these Official Rules or acting in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, each Station reserves the right to seek damages from any such person to the fullest extent permitted by law. Any Station’s failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
11. **Limitations of Liability.** The Released Parties are not responsible for: (a) any incorrect or inaccurate information, whether caused by Station, entrants, printing errors or by any of the equipment or programming associated with or utilized in the Contest; (b) technical failures of any kind, including but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (c) unauthorized human intervention in any part of the entry process or the Contest; (d) technical or human error that may occur in the administration of the Contest or the processing of entries; or (e) any injury or damage to persons or property that may be caused, directly or indirectly, in whole or in part, from entrant’s participation in the Contest or receipt or use, non-use or misuse of any prize. No more than the stated number of prizes will be awarded. In event that a production, technical, programming or other error causes more than stated number of prizes as set forth in these Official Rules to be claimed, Station reserves the right to award only the stated number of prizes by a random drawing among all legitimate, unawarded, eligible prize claims.
12. **Disputes.** Entrant agrees that: (a) any and all disputes, claims and causes of action arising out of or connected with this Contest, or any prizes awarded, shall be resolved individually, without resort to any form of class action; (b) any and all disputes, claims and causes of action arising out of or connected with this Contest, or any prizes awarded, shall be resolved exclusively by the United States District Court or the appropriate state court located in the Station’s listening area; (c) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Contest, but in no event attorneys’ fees; and (d) under no circumstances will entrant be

permitted to obtain awards for, and entrant hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE MAY NOT APPLY TO YOU. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of entrant and Stations in connection with the Contest, shall be governed by, and construed in accordance with, the laws of the state in which the Station is located, without giving effect to any choice of law or conflict of law rules (whether of the state in which the Station is located or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the state in which the Station is located.

13. **Entrant's Personal Information.** Information collected from entrants is subject to each Station's Privacy Policy, which is available on each Station's website under the "Privacy Policy" link. All entry blanks, forms, devices, and materials gathered during the course of entry, as well as all information contained therein, shall become the sole property of Stations to be used, disposed of or destroyed in its sole discretion. Stations are not responsible for any incorrect or inaccurate information entered by website users, and assumes no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to each Station's website.
