WZNS/Z96'S "MEGA MOM SHOPPING SPREE" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WZNS ("Station"), 225 NW Hollywood Boulevard, Fort Walton Beach, FL, during available business hours Monday through Friday, on the Station website at www.Z96.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the WZNS/Z96's "Mega Mom Shopping Spree" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. Send a text message with the keyword MOM spelled correctly to 850-664-0965 during the Contest Period. All entries must be received by 9:00 a.m. CT Thursday, May 11, 2023 to be eligible for a chance to win a prize. Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider. Limit one (1) entry per person per phone number.

- 4. **Winner Selection.** At or about 9:15 a.m. CT on Thursday, May 11, 2023 Station will select one (1) entry in a random drawing from among all valid entries received during Contest Period. The winning entrant will be contacted using the email address and/or telephone number provided with their entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station has the right (without obligation) to announce on the air each winner's name, city of residence, or any other part of the entrant's Contest entry. Station's decision as to the administration and operation of the Contest and the selection of the potential winners is final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within twenty-four (24) hours of notification will result in disqualification.

A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize.
